Eligibility

- Vermilion Local School District (VLSD) facilities; licensed child-care centers; parochial institutions Within the Ritter Public Library (RPL) service area (VLSD)
- A valid educator ID or state/government issued ID;
- A signed letter from the school principal, superintendent, or administrator. *Ritter
 Public Library has already obtained approval from VLSD for all eligible educators to
 obtain or renew an educator card for the 25-26 school year.

Card Use

- 75 item maximum
- 30-day lending period
- Items with no other patrons waiting may be renewed for an additional 30-days
- Items from other CLEVNET libraries may be requested, but loan periods may vary
- Cards must be in good standing to renew
- Materials to be utilized for in-class use only
- Personal use is prohibited, and students/educators may not remove the materials from the classroom/institution
- Educator privileges do not extend to digital materials

Fines/Fees:

- Materials owned by RPL do not accrue fees if returned late
- Items borrowed from other CLEVNET libraries may accrue fees

Damaged items

- Items unreturned following the end of the lending period are considered lost and a replacement cost will be attached to the card
- Fees assessed for damaged materials may include minor repair to the item or packaging, rebinding of books, or actual item replacement
- All charges are attached to the borrower's educator card record until paid

Billing

- RPL may forgive fees and damages on, up to but not exceeding, three (3) items
- Only items owned by RPL are eligible for forgiveness
- Cardholder assumes responsibility for notifying RPL staff if they have fees or damages in need of forgiveness
- Additional fines and fees are billed directly to the educational institution
